Official Rules and Regulations; 1966 Mustang Raffle

Entrants of the raffle may monitor the raffle ticket sales by logging into Yonah Lodge 382 Web site at www.yonahlodge382.org.....where up dated sales will be posted and date of drawing. Entrants do not need to be present to win. The winner will be notified by telephone and/or letter, according to the contact information provided on the ticket. In the event a winner cannot be contacted or fails to respond within 7 calendar days or fails to otherwise qualify for the prize and/or declines the prize, an alternate winner will be selected.
